EUR 2,000,000,000 Debt Issuance Programme

This supplement (the "Supplement") dated 13 February 2023 constitutes a supplement pursuant to Article 23 (1) of the Regulation (EU) 2017/1129, as amended (the "Prospectus Regulation") and is supplemental to, and should be read in conjunction with, the base prospectus dated 19 May 2022 (the "Original Prospectus" and together with the Prospectus Supplement 1 dated 23 August 2022 and with the Prospectus Supplement 2 dated 17 October 2022 the "Prospectus") for the EUR 2,000,000,000 Debt Issuance Programme (the "Programme") of Kommunalkredit Austria AG (the "Issuer"). The Prospectus forms the base prospectus of the Issuer within the meaning of Article 8 (6) of the Prospectus Regulation.

The Original Prospectus has been approved on 19 May 2022 by the Austrian Financial Market Authority (*Finanzmarktaufsichtsbehörde*, the **"FMA"**).

This Supplement has been filed with and approved by the FMA in its capacity as competent authority, filed with the Vienna Stock Exchange (*Wiener Börse*) and published in electronic form on the Issuer's website under "www .kommunalkredit.at/en/investor-relations/bondholder-information-funding/debt-issuance-programme/".

Terms defined in the Prospectus shall have the same meaning when used in this Supplement.

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference in the Prospectus by this Supplement and (b) any other statement in or incorporated by reference in the Prospectus, the statements mentioned in (a) above will prevail.

Save as disclosed in this Supplement, no other significant new factor, material mistake or material inaccuracy relating to the information included in the Prospectus has arisen or been noted, as the case may be, since the publication of the Prospectus.

In accordance with Article 23 (2) of the Prospectus Regulation, investors who have already agreed to purchase or subscribe for securities issued or to be issued by the Issuer before this Supplement was published have the right, exercisable within two working days after the publication of this Supplement, to withdraw their acceptances until, and including 15 February 2023, provided that the significant new factor, material mistake or material inaccuracy arose or was noted before the closing of the offer period and the delivery of the Notes, whichever occurs first. Investors may contact the relevant financial intermediary if they wish to exercise their right of withdrawal.

The accuracy of the information contained in this Supplement does not fall within the scope of examination by the FMA under the Prospectus Regulation. The FMA only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer that is the subject of this Supplement.

Significant new factors, material mistakes and/or material inaccuracies (as referred to in Article 23 (1) of the Prospectus Regulation) have arisen which in the Issuer's perception are capable of affecting the assessment of the Notes, and are thus herewith included in the Original Prospectus as follows:

In the section entitled "KOMMUNALKREDIT AUSTRIA AG" commencing on page 88 of the Original Prospectus, in the sub-section entitled "Organisational Structure – *Current Ownership Structure*" the last subparagraph shall be replaced by the following information:

"The two indirect controlling shareholders of the Issuer, Interritus and Trinity, have sold their entire stake in Satere to Green Opera Finance BidCo AB ("Green Opera") based in Sweden. The sale is subject to competition and regulatory approval. The current owners of Satere will each indirectly hold a 9.9 per cent. interest in the acquiring company Green Opera. This transaction will result in a change in control over the Issuer."
